## **Invitation for Bids**

Contract Title: The Supply and Delivery of Equipment for Agriculture Information

System (AIS)

- 1. The Kingdom of Cambodia has received a credit from the International Development Association (IDA) toward the cost of Cambodia Agricultural Sector Diversification Project (CASDP), and it intends to apply part of the proceeds of this credit to payments under the Contract for the Supply and Delivery of Equipment for Agriculture Information System (AIS) (MAFF-G-34).
- 2. The Ministry of Agriculture, Forestry and Fisheries (MAFF) now invites sealed bids from eligible and qualified bidders for the Supply and Delivery of Equipment for Agriculture Information System (AIS).
- 3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of World Bank.
- 4. This invitation is open to all bidders.
- 5. Interested eligible bidders may obtain further information from Ministry of Agriculture, Forestry and Fisheries (MAFF) and inspect the Bidding Documents at the address given below from 8:00 AM to 12:00 AM and 2:00 PM to 5:00 PM, from Monday to Friday, except government public holiday.
- 6. Qualification requirements include:
  - (a) The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
    - (1) The Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years (1 January 2022 to 31 December 2024) of not less than USD 160,000.00 per contract.
    - (2) The Bidder has completed contracts in the total cumulative amount equal to at least USD 640,000.00 in the preceding two years (1 January 2023 to 31 December 2024).
    - (3) that the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods;
    - (4) that the Bidder has availability of liquid assets through either:

- (i) access to a line of credit or cash in bank account of an amount at least USD 160,000.00 net of other contractual commitments; or
- (ii) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
- 7. A complete set of Bidding Documents in *English* may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee *35.00 US Dollars* or its equivalent in Cambodian Riel being *140,000.00 KH Riel*. The method of payment will be in cash or deposit to Bank Account No. 000000013535, Account Name: Ministry of Economy and Finance at National Bank of Cambodia. The Bidding Documents will be sent by airmail for delivery outside of Cambodia and by courier for local delivery or may be collected in person at the discretion of the bidder.
